Dear Governor Scott & Members of the General Assembly:

The Staff and Directors of the Vermont Municipal Bond Bank (the "Bond Bank") are pleased to submit to you our Annual Report for the 2018 calendar year. This past year marked the Bond Bank's 49th year of facilitating local infrastructure projects across Vermont.

The Bond Bank's mission as an instrumentality of the state is to finance social and physical infrastructure for governmental units across Vermont. This is accomplished through our pooled loan program and participation in the Clean Water and Drinking Water State Revolving Funds in partnership with the Department of Environmental Conservation.

The pooled loan program is the primary focus of the Bond Bank. As of the end of 2018, our portfolio consisted of 490 loans with a total outstanding balance of \$548 million across 218 borrowers. This activity is supported by our strong bond rating of "Aa2" and "AA+" from Moody's and S&P, respectively.

The last year provided another opportunity to improve the well-being of Vermont's communities. Over the course of the year, the Bond Bank loaned \$40.4 million for new projects within the pooled loan program. This included 23 loans with a median size of \$1 million.

In 2018, the Bond Bank instituted an impact monitoring program with information provided by our borrowers. The projects financed as part of the pooled loan program will serve over 113 thousand Vermonters while resulting in outcomes such as reduced energy consumption, facility renovations, and streetscape improvements.

The following pages of this report include more information on the Bond Bank's impact over the course of the past year as well as an overview of the pooled loan portfolio as of December 31, 2018.

Thank you for your continued support in helping us to finance critical infrastructure through the state.

WHAT WE ARE

The Vermont Municipal Bond Bank was created by the Vermont legislature in 1969 to assist eligible governmental units access public financing markets. The Bond Bank is governed by a five-member Board of Directors with four appointed by the Governor and the State Treasurer serving as an ex-officio member.

The Bond Bank underwrites provides municipal loans for local infrastructure projects through the pooled loan program. Loans are primarily financed through the Bond Bank's issuance of publicly offered tax-exempt bonds.

On an on-going basis, the Bond Bank services its loans and provides outreach and planning assistance to potential borrowers.

The Bond Bank also co-manages the State's Revolving Funds with the Department of Environmental Conservation. Loans are issued for the planning and construction of municipal drinking water and clean water projects.

To support Vermont's municipalities and other qualified bodies in making informed and knowledgeable financing decisions for present and future generations.

VISION

To assist Vermont's municipalities and other qualified public bodies in gaining access to affordable, innovative and appropriate financing to meet their capital needs.







OUR IMPACT

The Bond Bank's pooled loan program contributes to community well-being by facilitating social and physical infrastructure projects throughout the state. The Bond Bank instituted a voluntary impact reporting program as part of the pooled loan program in 2018. Over the course of the year, Bond Bank financed projects were estimated to contribute:

TOWN OF CHESTER

WINDSOR COUNTY

POPULATION: 3,200

ISSUE

The Town had multiple planned capital improvements that needed to be financed after three successful bond votes.

BOND BANK SOLUTION

The Bond Bank approved a loan in the amount of \$669 thousand that financed the Town's three voter approved bond authorizations. The Bond Bank was able to offer a one-stop shop and consolidated the various needs into one loan. Included in the projects financed were a town hall renovation and the construction of a pocket park. The park was the first action undertaken by the Town to implement the recommendations of its Master Plan, which was completed after several years of work. The park was completed in summer of 2018.







VILLAGE OF SWANTON

FRANKLIN COUNTY

POPULATION: 2,600

ISSUE

The Village electric department was well underway with the logistics of replacing a rubber dam on the village hydroelectric plant when it unexpectedly broke in summer 2017. Voter approval was quickly received and a long term source of finance was needed.

BOND BANK SOLUTION

The Bond Bank approved a loan for long term financing of the repairs in the amount of \$2.2 million. The long-term loan refunded an interim credit facility used to purchase the replacement rubber dam. The project was of key concern to the community as it ensured a renewable source of power for customers who have one of the lowest electric rates in the state. At full capacity, the dam can produce up to 58 thousand MWh annually. The replacement rubber dam was installed in the summer of 2018.





ADDISON NORTHWEST SCHOOL DISTRICT

ADDISON COUNTY

ENROLLMENT: 1.000 students

ISSUE

The District was planning to undertake multiple improvements at all four of its district campuses. The largest improvements related to energy efficiency upgrades subject to an energy performance contract. The District hoped to secure a low cost of capital for the improvements to maximize the budgetary savings related to reduced energy use.




The Bond Bank approved the District's request for financing in the amount of \$7.63 million. The District will draw on the funds over the course of a year while undertaking the improvements. In total, the energy efficiency upgrades are expected to save the District over \$200 thousand annually by reducing energy consumption by approximately 275 thousand kWh. All improvements were completed in 2018.





2018 BOND BANK TRANSACTIONS

The Bond Bank issued \$41.165 million in bonds during 2018 to support new loans in the pooled loan program.



Over the course of the year, the Bond Bank undertook significant steps to increase the ability of Vermonters to invest in their communities through the Bond Bank's bonds.

Key to this effort was the designation of Local Investment Bonds, both to highlight the local impact of the projects capitalized by the Bond Bank's bonds and to alert individual investors to the reduced barriers to investing in Vermont's local communities through the \$1,000 denominations.

Local Investment Bonds

The Bank self-designated the 2018 Bonds as Local Investment Bonds. This designation is intended to reflect the local impact of the projects that are capitalized by the 2018 Bonds. Moreover, the designation is also intended to alert individual investors to the reduced barriers to investing in Vermont's local communities through the \$1,000 denominations of the 2018 Bonds.

The Bank has a history of financing projects similar to those capitalized by the 2018 Bonds while providing access to capital for communities throughout Vermont.

The Bank recently began a best efforts program to quantify the impact of the Bank's activities and intends to summarize impacts through the Bank's annual report. While the Bank is not required to disclose impacts, it expects to do so on a voluntary basis as data is available. The 2018 Bonds are the second series of Local Investment Bonds issued by the Bank.

Estimated impacts for projects capitalized by the 2018 Bonds include:

- · Over 600,000 square feet of facilities upgraded
- Nearly 360,000 kWH of energy efficiency savings and/or renewable energy produced
- Over 95,000 people directly served by the projects
- Over 11,000 linear feet of streetscape improvements, including multi-purpose paths and sidewalk improvements
- Over 6,700 student seats enhanced
- Over 70 construction jobs created
- One pocket park created
- One fire truck purchased

STATE REVOLVING LOAN FUND ACTIVITY

The Vermont Department of Environmental Conservation and the Vermont Municipal Bond Bank jointly administer the Clean Water State Revolving Fund and the Drinking Water State Revolving Fund programs. Both programs are funded through a combination of Environmental Protection Agency dollars and state matching funds.

In 2018, the Bond Bank provided credit review and financial underwriting on:

- 61 loan agreements or amendments reviewed and approved
- \$28.4 million in loan agreements or amendments reviewed and approved

The above activity will help to upgrade infrastructure in 42 communities.

In addition, the Bond Bank provides on-going loan servicing of the portfolio to ensure loan repayment and timely processing of payment requests during construction. The portfolio includes \$248.2 million in loans for 197 unique borrowers.

CLEAN WATER STATE REVOLVING FUND



Program provides low-interest loans for water quality protection projects to make improvements to wastewater treatment systems, control pollution from stormwater runoff, and protect sensitive water bodies.



DRINKING WATER STATE REVOLVING FUND



Program provides low-interest loans for source protection, oversight of system operations, and training, as tools for ensuring safe drinking water.
