



Small System Capacity and Resiliency Program (SCRP) Tier 2 Round 2 Grant Application Period Now Open

The Vermont Bond Bank (VBB) is now accepting applications for a second round of Small System Capacity and Resiliency Program (SCRP) Tier 2 grants to small drinking water systems at risk of failure.

The Bond Bank anticipates awarding approximately \$5.7 million in Tier 2 grants over time, with \$1 million available in this round. SCRCP was created with a State of Vermont American Rescue Plan Act (ARPA) grant in collaboration with the Vermont Department of Environmental Conservation (DEC). All public Vermont drinking water systems serving 10,000 or fewer (largely residential) customers are eligible.

Applications for this round of SCRCP Tier 2 grants are due October 29, 2025, by the end of the day. Awards will be announced in early December. Funds will be available soon after for requisition.

SCRCP Tier 2 Overview

The intent of SCRCP Tier 2 is to provide small drinking water systems with grants for the replacement of infrastructure at risk of failure. Please review the following tables for details regarding eligibility, requirements, terms, and prioritization criteria.

SCRIP Tier II Terms (Initial 2024 Funding Round)	
Amount	Up to \$250k
Eligible Applicants	Vermont governmental units serving 10,000 or fewer (largely residential) customers with drinking water
Eligible Uses	Planning for and replacement of drinking water infrastructure in compliance with the EPA's DWSRF handbook
Approval / Review	Subject to Bond Bank review – inc. Bond Bank consulting engineer review to verify conformity with the DWSRF handbook
Flow of Funds	Requisition requests with invoices reviewed and approved by Bond Bank and/or consulting engineer prior to release
Reporting	Project completion report describing project outcomes and explaining the financial and managerial sustainability plan required. Additional updates (financial, progress, etc.) may also be required upon request of the Bond Bank.

Prioritization of Available Funding

The Bond Bank anticipates oversubscription and will make every effort to provide meaningful funding to the greatest number of communities and individuals – with the following criteria used to inform the prioritization process. The Bond Bank reserves the right to modify these criteria to advance program objectives.

Criteria	Description	Weight
System Vulnerability	Ranking on the State of VT Community Index	25%
Household Rate Burden	Combined household cost of total utility rate burden	25%
Commitment to Sustainability	Commitment to sound financial and managerial planning	25%
System Size	Smaller systems will receive greater consideration	25%
